

*The following contest is intended for residents of the province of Quebec and Ontario, Canada, and will be interpreted and judged under Canadian law. Enter only if you are a legal resident of the province of Quebec or Ontario.*

## **OFFICIAL RULES OF THE "Quebec International Pee-Wee Hockey Tournament Private Box Contest" (THE "OFFICIAL RULES")**

The "Quebec International Pee-Wee Hockey Tournament Private Box Contest" (the "**contest**") is offered by Irving Oil Limited ("**Irving**").

**1. General information:** No purchase necessary. Each Participant may enter the contest only once and any other entry made by such Participant shall be deemed invalid. **2. Contest dates:** The contest begins at 12:01:01 a.m. Eastern Time ("**ET**") on January 8, 2025 (the "**contest start date**") and ends at 11:59:59 p.m. ET on January 24, 2025 (the "**contest end date**"). The period from the contest start date to the contest end date is referred to as the "**contest period**".

**3. Who can participate:** Any Participant in the Irving Rewards Program (<https://www.irvingoil.com/en-CA/on-the-road/irving-rewards>) who is domiciled in the province of Quebec or Ontario and who has reached the age of majority at the contest start date may participate. Employees of Irving, its affiliates and agents, its contracting parties and members of the immediate family (i.e. parents, children, siblings and spouse) of each employee, as well as persons with whom such employees reside, are not eligible to participate in this contest.

**4. How to enter the online sweepstakes:** Log in to your Irving Rewards Account and follow the instructions at the bottom of the screen to enter the contest. You will need to click on the "Enter here" button to be automatically added to the contest. A pop-up window will appear confirming your registration. All online entries must be made on or after 12:01:01 a.m. on January 8, 2025, and before 11:59:59 p.m. ET on January 24, 2025, to be eligible for the sweepstakes described in Section 5 of these Official Rules.

**5. Online sweepstakes prize draws:** A total of six (6) online prizes to be won consisting of six (6) lots valued at \$185 each, namely (a) five (5) tickets for a game at the Quebec International Pee-Wee Hockey Tournament on February 22, 2025, valued at \$50 each, and (b) a promotional bag containing various items and accessories. Each online winner will be randomly selected amongst all eligible entries not already selected and received by 11:59:59 p.m. ET on January 24, 2025.

Exclusions: Prizes are nontransferable and cannot be substituted with cash, in whole or in part. Irving reserves the right to substitute an advertised prize with one of equal or greater value, if such prize is no longer available. Prizes are awarded only to eligible winners.

**6. Notification and awarding of prizes - Online sweepstakes:** If your name has been selected in one of the online sweepstakes, Irving will notify you by e-mail. If the winner does not respond to Irving's e-mail within forty-eight (48) hours of Irving sending such e-mail, the winner will be disqualified and a new winner will be selected, and so on so forth. In order to receive his prize, the winner must sign and return, within seven (7) days of receipt of notification, the declaration of eligibility and release of liability confirming, among other

things, (1) compliance with these rules, (2) answer, unaided, a mathematical skill testing question and (3) release Irving and other third parties from all liability.
